Implementation of RSA SecurID Tokens for GinnieNET Users

Information concerning the next steps for implementing RSA SecurID Tokens in lieu of biometric (fingerprint) scanners in GinnieNET, including information for existing GinnieNET Enrollment Administrators and GMEP Security Officers will be addressed during the Modernization Outreach Call scheduled for August 20, 2015. Ginnie Mae will afford all Issuers and Document Custodians sufficient time to complete the steps necessary for this next phase of implementation.

However, before proceeding to the next phase, Ginnie Mae would like to ensure that any GinnieNET user that performs submissions through GinnieNET has or obtains a Ginnie Mae issued RSA SecurID Token. To obtain a token, please submit the [RSA SecurID Token Request Form](#) to a GMEP Security Officer in your organization.

Updated Guidance for Completing the RSA SecurID Token Request Form

To avoid unnecessary delays in the processing of your RSA SecurID Token Request Form, please provide the GMEP ID, not the GinnieNET ID, of the Security Officer and requesting users in Section II and Section III of the form. Also, please note that the signature block in Section III must reflect the signature of the user requesting the token, not the signature of the Security Officer. Lastly, please remember that only users who are Authorized Signatories on Form HUD-11702 may request a token for completing submissions in GinnieNET.
