README NOTE: The Forbearance Pool Level File supplements and “parallels” the current enhanced Ginnie Mae MBS Single Family Pool Disclosure in terms of the file format, the header and trailer, and stratification record format. There are 4 pool stratification record in this Forbearance Pool Level Disclosure file: Records “90”, “91”, “92” and “93”. It has the same primary key fields of Record Type, CUSIP, Pool ID, Pool Indicator and Pool Type. These correspond to the same key information in the Ginnie Mae MBS Single Family Pool Disclosure file, and can be used to match or link the records in this forbearance disclosure file to the corresponding records in the current monthly enhanced pool level file.

Introduction

The MBS Single Family Forbearance Pool Level Disclosure file is a standalone disclosure file that provides pool aggregate information related to borrower forbearances in Ginnie Mae Single Family MBS. The aggregate information in this file is dependent on and aggregated from issuer reporting. The file provides pool information derived from issuer reporting of forbearance at the loan level.

This document provides the technical specification for the file layout, record types, and data for the Single-Family Forbearance Pool Level Disclosure.

Summary of the Record Types in the File.

Record Types	The record types are the standard stratification/enumeration format. There are four Record Types with basic information about the Pool; it provides the aggregate UPB, Loan Counts and enumerations for the pool. Record type 90 is a single stratification on Forbearance Type. Record types 91, 92, and 93 are 2-field stratification records.
Flexible Format	All Records are produced as text format with Pipe () delimited separation between fields. The files will be published in compressed (zip) format.
Population of Records and Fields	A Record will be produced only for pools with forbearance loan data. There can be occurrences of “ ” bar-bar where there is no data value for a field. Records are “data driven” and therefore individual enumerations are based on the characteristics of the underlying loan level data, as reported by the issuer.
Explicit Decimal Point	For fields that have values with decimal points, records will explicitly include the decimal point.
Sort Order of Records	Records will be sorted by Pool ID in ascending order; Record Type within Pool; Field Value(s) within Record Type.
Monthly Portfolio	File will be produced monthly for Monthly Portfolio. There is no new issuance file.
